Number of Shelters:	6 shelters (Dimensions - 12'W x 14'L)
Maximum Persons Per Shelter:	4 persons
Furnishings:	One table, Two wooden platforms (Each platform 2-1/2' W x 14'L for sleeping bags provided by occupant) Electrical lights; electrical outlets (For in-shelter use only)
Rate:	\$40.00 per shelter per night (resident) \$70.00 per shelter per night (non-resident) 10% Administrative Fee on Total Charge \$3.00 Change Fee
Shared Comfort Station:	Hot water shower and flush toilets. Comfort Station #1 for Shelters 1, 2 and 3; Comfort Station #2 for Shelters 4, 5 and 6.
Check-in Time:	3:00 p.m. with caretaker at Maintenance Building Office
Check-out Time:	10:00 a.m.
Shelter Access:	Combination Locks – Access Code required. Instructions on permit.

**INFORMATION AND RULES**

1. Please conserve energy. Turn off lights when not in use.
2. Occupants must clean their shelter before leaving.
3. Keep pavilion and cooking facilities clean - discard leftovers.
4. No pets or animals permitted except service animals performing their service duties as defined by the Department of Justice under ADA (Americans with Disabilities Act).
5. Division of State Parks will not be responsible for any personal articles stolen, left or lost by occupants.
6. No fires permitted in or outside of shelters.
7. No campers, trailers or tent camping allowed.
8. No nails to be used in building.
9. Comfort Stations and cooking facility use by permitted occupants only. Access code required.
10. When vacating, please lock shelter.

Information on Hawaii State Parks as well as permits may be obtained online through our State Parks website at [www.hawaiistateparks.org](http://www.hawaiistateparks.org) or in person at any of our Division of State Parks District Offices, Monday through Friday, except State holidays from 8:00 a.m. to 3:30 p.m. HST. Persons must be 18 years or older to obtain a permit. Maximum stay of 5 consecutive nights at any one park. After any lodging stay, permittee or anyone listed on permit must wait 30 days before staying overnight again in the same park. Only one shelter can be reserved at a time.

Payment shall be in full in cash, cashier's check, certified check, money order or credit card when acquiring a permit at the District Offices or by credit card when reserving online. Personal or business checks will be accepted only if payment is received more than 30 days of the event date. Checks are to be made payable to Department of Land and Natural Resources. A \$25.00 service charge shall be assessed on all returned checks.

Permit fees, less cancellation charges (\$5) and processing fee (\$10% of total charge) will be refunded or credited only if request is received a minimum of 15 days prior to the check-in date shown on permit. Credit for credit card payments may be processed if cancellation is done within 45 days of the credit card purchase. No changes will be accepted to an existing permit less than 7 days prior to the check-in date shown on the permit.
