This facility is provided for public recreation. Improvements are somewhat limited, however, they are adequate for an enjoyable outing experience. Please help us maintain and continue to make this facility available by observing the following rules and guidelines:

- 1. A CHARGE of \$30 PER NIGHT (Hawaii residents) or \$50 PER NIGHT (non-residents) will be assessed along with a 10% non-refundable handling fee. Permits must be purchased online at the DLNR camping website (camping.ehawaii.gov). Call 808-974-4221 for more information.
- 2. Unless arranged otherwise, the cabin and gate keys will be issued to the individual named as the purchaser of the permit and that individual will be asked to place a \$60 (cash only) REFUNDABLE key deposit and present a picture identification upon picking up keys. Keys can be picked up at the DOFAW Hilo Office (19 East Kawili Street, Hilo, HI) or DOFAW Waimea Office (66-1220A Lalamilo Road, Kamuela, HI) during business hours. Cabin accommodates up to five (5) persons; length of stay to be no more than two (2) nights/three (3) days.
- 3. Permits must be purchased between SEVEN (7) AND THIRTY (30) days prior to the exact date of campout.
- 4. To allow use opportunities for a maximum number of people, PARTIES ARE LIMITED TO STAYS OF ONE (1) WEEKEND ONLY DURING A SIX-MONTH PERIOD (FRI-SUN). Weekdays may be reserved as available with no limitations.
- 5. Use of the Ranger Cabin Facility ONLY is permitted.
- 6. Facilities consist of:
 - Living Room with two (2) bunks AND NO MATTRESSES. YOU MUST PROVIDE YOUR OWN SLEEPING BAG AND/OR MATTRESS.
 One bedroom with one (1) bunk only AND NO MATTRESS. YOU MUST PROVIDE YOUR OWN SLEEPING BAG AND/OR MATTRESS.
 One bedroom with two (2) bunks AND NO MATTRESSES. YOU MUST PROVIDE YOUR OWN SLEEPING BAG AND/OR MATTRESS. A.

- 2. Unless arranged otherwise, the cabin and gate keys will be issued to the individual named as the purchaser of the permit and that individual will be asked to place a \$60 (cash only) REFUNDABLE key deposit and present a picture identification upon picking up keys. Keys can be picked up at the DOFAW Hilo Office (19 East Kawili Street, Hilo, HI) or DOFAW Waimea Office (66-1220A Lalamilo Road, Kamuela, HI) during business hours.
